## ***Stay Safe and Enjoy the Rest of the Summer!***

Although crime pressure around the lake has been minimal, we have begun to hear reports of isolated home burglaries. Please use this opportunity to double down your crime prevention efforts and ensure storage sheds are locked and car doors locked when the vehicle is parked. Don't leave things of value in the open. Use of timers, stout 1 inch deadbolt locks and security cameras are good deterrents. Most importantly, be vigilant in your neighborhood. If something doesn't look right like a strange car in the neighborhood, when in doubt call 911.

If you don't have one of our "In Case of Emergency" orange cards, please let us know. These cards document location details of your residence and boat dock for guests and renters and help first responders find the address if the caller is using a cell phone.

The recent tropical storm that passed by the lake was a good teachable moment to secure items at boathouses and on decks. By the time you read this we will be in the teeth of the hurricane season. Hope you have purchased extra batteries in case you lose power.

In other news, the Northampton County Emergency Services has recently completed their first training CERT class. Planning is underway for a second class and if enough lake residents sign up, the class will be offered near the lake. ## News from the Lake Environment Committee

### **E. coli testing**

We are once again making Coliscan Easy gel water test kits available to volunteers. This is a simple, accurate and quantitative way to identify and differentiate coliforms and E. coli (true fecal coliform). The presence of fecal coliform bacteria indicates contamination by human and/or animal fecal material. If E. coli is present in water, disease-causing bacteria may also be present. With the exception of Miles Creek in the upper reaches of the Lake our tests have not detected significant amounts of E. coli.

### **“Hands on Habitat” Improvement**

We had some great weather for our “hands on” habitat improvement work this June. Over three days 23 volunteers contributed 271 hours of their time to help develop native vegetation. Aquatic vegetation is an important component of productive fish and waterfowl habitats. Native vegetation anchors bottom sediments, stabilizes shorelines, and removes nutrients. All of this is beneficial to water quality.

Our volunteers worked with members from the NCSU Aquatic Plant Management Team, North Carolina Wildlife Resource Commission, as well as Virginia Wildlife Resources. We installed one new “cage” in upper Great Creek, repaired numerous cages, harvested and replanted native vegetation at several sites.

Funding is provided by the Lake Gaston Weed Control Council and the Sport Fish Restoration Program. Since 2014, LGA volunteers have participated in this project. Each year we continue to see native vegetation grow and expand.

Thanks to all who volunteered this year. You can be proud of what you are doing to improve habitat and the health of Lake Gaston.

### **Fall Vegetation Survey Plans**

Plans for our fall volunteer vegetation survey are now underway. Volunteers float and survey aquatic vegetation along the shoreline (both emergent and submerged) and report using electronic notepads. This information is used along with sonar data to determine the location and density of vegetation and algae for integrated management planning.

Jessica Baumann, Extension Associate for Lake Gaston with NC State University’s Aquatic Plant Management Program has developed several tools to manage the survey including a training video, electronic sign up form and map displaying where survey work is planned and completed. Jessica is in the process of updating these tools and they should be available to us mid-August.

## News from the Government Relations Committee

The dust has settled and the County budgets have been approved for FY2021-2022. The local county fiscal year runs from July 1 to June 30.

The information below is our annual posting for each county of the total budget, the ad valorem tax rate, and funding to the Lake Gaston Weed Control Council (LGWCC) for noxious weed control.

County	Total Budget (1)	Tax Rate per \$100 (2)	LGWCC Funding (3)
Halifax, NC	\$ 48,160,011	0.76	\$ 58K
Northampton, NC	\$ 36,688,700	0.905	\$116K
Warren, NC	\$ 36,543,135	0.81	\$116K
Brunswick, VA	\$ 49,986,099	0.65	\$ 90K
Mecklenburg, VA	\$240,527,042	0.42	\$116K

(1) Note that Virginia counties are funded differently than North Carolina counties, which results in higher budget totals, but lower ad valorem tax rates.

(2) NC: Halifax stayed the same, Northampton went down from 91 cents, Warren stayed the same

VA: Brunswick up 12 cents and Mecklenburg stayed the same as last year.

(3) All five counties continued with the same LGWCC funding as FY2020-2021

The Government Relations Committee is a non-partisan activity that focuses on monitoring and interacting with our local and, to some extent, state governments. Our common goal is to represent the interests of our membership on matters that affect the Lake Gaston area.

There has been no new release of information on the two major lake developments – (Community Center at Edwards Beach & Chateaux on the Lake) that we have been following. The committee will resume our meetings as issues arise.

For example, members can attend a local county Commissioner/Supervisors meeting and witness your government in action. It only takes an evening a month or less (we can switch off with other members) and can be very interesting.

A picture is worth a thousand words. By now you have probably seen or heard about the boat who flew over the guardrail and landed on Lizard Creek Road at 12:15 on a Sunday morning. A photo is on the [www.LakeGastonWaterSafetyCouncil.com](http://www.LakeGastonWaterSafetyCouncil.com) web site. Fortunately, the two occupants were not injured. A miracle might be a better word to describe the final outcome.

Lessons learned: The renters were from another state and obviously didn't know their surroundings. They were going way too fast in less than ideal boating conditions. We don't know if drinking was involved but clearly the skipper had no clue where he/she was at upon impact.

We can't stress enough the importance of situational awareness and there is little margin for error on the water.

Some good discussion on social media about why the USCG patrols Lake Gaston during holidays. We wish they were here more but for those in doubt; trust us they have a legal right to be here. An operator on a jet ski over the July 4<sup>th</sup> holiday found out the hard way.

NC Wildlife reports there were 29 boat related drownings on NC lakes in 2020. 18 were not wearing a life jacket. The water is still warm and boating is ideal. Please be careful out there and watch out for the other guy.

## ***Buoys placed in Lake Gaston need state & federal approval***

Dominion Energy as well as the Virginia Department of Game & Inland Fisheries and North Carolina Wildlife Resources Commission have received complaints concerning buoys being placed in the lake to deter boats near boat docks.

Both Virginia Department of Game & Inland Fisheries and North Carolina Wildlife Resources Commission, as well as Dominion, do not allow buoys to be placed in the lake without state and federal approval. Any buoys placed in the lake will be considered an obstruction to navigation and will be required to be removed.

4. For issues related to boating safety and regulations:

In **North Carolina**, WRC enforcement officers are the point of contact. If there is an urgent concern about safety or violations, please call the enforcement hotline at 800-662-7137 and the dispatch center will contact the nearest officer on duty. General complaints should probably be directed to Col. Jon Evans at 919-707-0036.

In **Virginia**, VA Conservation Police Officers (CPO's) enforce boating safety laws. Violations in progress should be reported to the Wildlife Crime Line at 1-800-237-5712 or [WildCrime@dgif.virginia.gov](mailto:WildCrime@dgif.virginia.gov) .

**America's Boating Course** is an eight-hour course covering the basics of boating and is appropriate for youth as well as the adult boater. Successful completion of this course satisfies the education requirement to operate a boat in **ANY STATE** and for youth to operate a PWC in both Virginia and North Carolina.

**Virginia Law** : All Virginia boaters in the waters must have proof of taking a Boating Course.

**North Carolina Law:** Requires that all PWC and Motor Boat Operators born after 1 Jan 1988 will have proof of completing a Boating Course, if they are operating a vessel with a 10 HP engine or greater.

There are challenges associated with Emergency Medical Services (EMS) and 911 Operations when using a cell phone around Lake Gaston. Cell phones can not find your location like landlines when calling 911. And cell phones don't always work in rural areas around the lake. If First Responders can not find you then they can not HELP you.

Always call 911 first. If you do not get through to the proper county, use these alternate emergency numbers:

**Mecklenburg County, VA - 434-738-0028**

**Halifax County, NC - 252-583-7051**

**Northampton County, NC - 252-574-1041**

**Warren County, NC - 252-257-3456**

Another way to tell the 911 operator where you are located is with the **what3words** app which can be downloaded to your phone. The **what3words** app has given every 10 ft square in the world a unique combination of 3 words. Open up the app and wait for the GPS dot to stabilize. Tap the current location icon. The 3 word address appears on the screen. Read the 3 words to the 911 operator or tap "share" for additional information.






