## LGA Annual Membership Meeting Minutes - Unapproved Saturday, June 17, 2023, at 9:30 am Lake Gaston Baptist Church, Gymnasium

Member Check-in (9:15 - 9:30 am) took place in gymnasium.

Welcome to all and meeting was called to order by President Brian Goldsworthy @ 09:47 AM. Board Members in attendance: B. Goldsworthy, J. Zimmer, L. Mustian, A. Wood, S. McAllister, J. Waters, C. Warfel, and E. Wooster. Also, in attendance Executive Director B. Summerfield. Total attendance was 37.

Brian led attendees to the Pledge of Allegiance and a Moment of Silence asking for remembrance of Director Lew Stringer.

Brian asked for Approval of today's Agenda, motion was made by Eric Wooster and seconded by Lewis Mustian. Motion passed.

Brian made several announcements; committee and board meetings will begin to be held at Lakeland Cultural Arts Center (LCAC) studio B, LCAC will begin holding outdoor concerts (June 24 through August on Saturdays 5PM) and is in need of volunteer ushers, August membership meeting will be an evening dutch treat at Watersview, please RSVP so we can have headcount by July 22<sup>nd</sup>.

Anne Wood provided a Treasurer's Report (YTD through May), a copy of this report was made available to attendees today. She noted that majority of expenses are typically in the summer & fall period. We are now using a software package that provides auto invoice for membership dues.

Jeff Zimmer, (Acting Secretary) stated that last year's (2022) Annual Membership meeting minutes were taken by Don Carson and are posted on our web site. A copy of these was available to attending members today. Jeff asked for a motion to approve these minutes. Eric made a motion to approve these with a second made by Lewis. Vote taken and minutes were approved.

## **New Business**

Brian brought forward a proposal to amend the Bylaws (dated June 11, 2011 with revisions) for consideration. These amendments were proposed by a committee chaired by John Cataldo. The proposed bylaws were made available to the membership in the February/March 2023 Bulletin. Motion to accept the proposed bylaws was made by Lewis, and seconded by Eric. Discussion followed; Judy stated that she thought the bylaws had been amended previously in 2020. These are Brian (ending his 2<sup>nd</sup> term) and Jeff (ending his 1<sup>st</sup> term).
